EMPLOYMENT TAX SERVICES

Employment tax, including PAYE and National Insurance Contributions (NIC) can be complex and confusing and getting it wrong can be very costly. In the event of a compliance visit by HM Revenue & Customs they could seek not only PAYE and NIC but interest and potential penalties on any non-compliance under the PAYE and/or Social Security Regulations. At Income Made Smart LLP we provide specialist services in compliance and planning and by taking proactive action this can avoid unpleasant surprises.

By way of example below are some of the services we can provide:

- PAYE/NIC review of policies and procedures, including expenses claims to ensure compliance for tax and NIC and that the correct reporting procedures have been applied. This can include a tailored specific review of travel and subsistence expenses for example.
- Review of existing Dispensations from P11D Reporting and assistance with applications for a new or revised Dispensation to ensure it is as up to date and as comprehensive as possible.
- An Employment Status Review – a full review of all payments made to individuals on the basis they are self-employed to identify any exposure to tax, NIC, interest and potential penalties.
- A review of payments made or to be made on Redundancy/Termination, including Compromise Agreements and the tax/NIC treatment applied.
